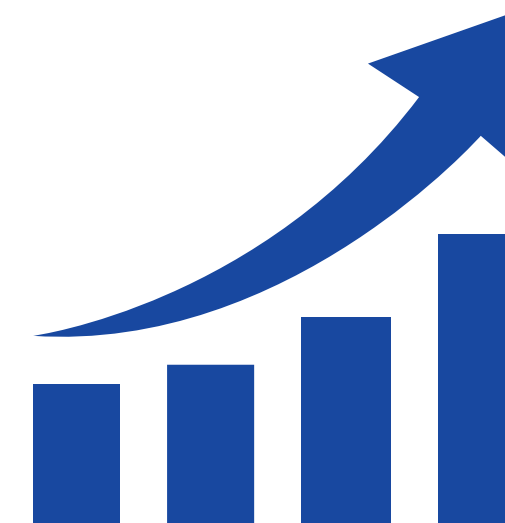

PP&F BRANCH POST SOUND TERMS OF ENGAGEMENT:

a) Cancellation:

Confirmed bookings (where the provider of the service has agreed in writing to accept the work and not accept other work for the agreed dates) are subject to the following:

- 1) a 25% cancellation fee of one week if cancelled with 11 working days or more notice.
- 2) a 100% cancellation fee of one week if cancelled within 3–10 working days notice.
- 3) a 100% cancellation fee of two weeks if cancelled with 2 or less working days notice. A booking will be considered confirmed if not cancelled in writing 5 business days before commencement.

b) Delays/Pushed Start Dates:

Any delay to a confirmed start date of between 1 and 15 working days will be subject to a 20% fee of the agreed rate for the length of the delay. Any delay longer than 15 working days will be treated as a cancellation and subject to cancellation charges. Any new start and end date will be subject to agreement.

c) Hiatus & Suspensions:

Once work has started, any interruption to work not originally agreed must be agreed in advance and will be subject to a 50% retainer for the duration of the delay. Any new end date will be subject to agreement.

d) Termination:

Once work has commenced, a minimum of one week's notice in writing is required for both parties.

e) Payment terms:

Within 14 days of invoice or the next scheduled payroll run, whichever is the sooner. Payment after 30 days is subject to statutory late payment charge and interest.

f) Working week:

Will consist of 5 days of 8 hours per day unless otherwise agreed. Additional hours or days worked in excess of this at the request of the engager will be agreed in advance and will be charged at the Editor's overtime rate.

g) Insurance:

Any items provided by the engager, (including items hired by the engager from a 3rd party) must be covered by the engager's or 3rd party provider's insurance. Travel insurance must be provided by the engager or production company for international bookings.

This list is not exhaustive. Engagers should bear in mind that these terms are the assumed terms of engagement.

Variations to these terms must be agreed by both parties in advance.
